1. Apologies for absence

2. Declarations of Interest

5. Items for discussion

a. Speeding and Overweight HGV traffic

Concerns amongst residents in the Village are ongoing regarding the number of speeding vehicles through the village and the volume of HGV's flouting the 7.5t limit.

The following email was sent by Chair C Williams as part of the Parish Council's ongoing activity to find options to resolve these issues.

Good Afternoon Nick

The Parish Council wishes to instigate measures to

- a) control vehicle speeds within the village and
- b) to effect greater adherence to the 7.5 ton limit applicable to The Street, Long Row and the apparently unnamed road that crosses Castle Eaton bridge heading north then east up to the C124, the road to Kempsford, and vice versa. We have already consulted with the Police and understand
- i) the installation of cameras observing HGV traffic, contravenes GDP law and is therefore not an option and
- ii) that for any actions against unauthorised HGVs, it has to be a Police Officer that observes such illegalities.

We would like to explore Speed Indicator signs adjacent to the three entrances to our village (from Hannington, Kempsford and Water Eaton), plus the possibility of rumble strips being installed on the approaches to the 30mph signs already installed.

There is also the anomaly caused by the boundary of Wiltshire CC and Swindon BC on the C114, Water Eaton Lane. This boundary is about 170 metres from the 30mph sign on entry to the village when heading north east along Water Eaton Lane. Wiltshire CC have set a 40mph speed limit. At the point their authority passes to Swindon, the speed limit is reset to No Limit. However after 170 metres, the Castle Eaton entrance 30mph signage is set. We think there is a risk to life here as non-locals mostly accelerate from the No Limit sign into a narrow area with no pavements and a left turn into Droveaway, from which traffic seeking to exit is blinded by high hedge growth. Ideally we would like the No Limit sign replaced by a 40mph sign, effectively continuing the Wiltshire CC limit up to the Castle Eaton boundary.

Please let me know what is possible, along with costs (if any possible remedy would not be funded by SBC).

We have a Parish Council meeting on Monday 20th July in the village hall, starting at 7pm. You would be most welcome.

The Parish Council would like to explore installing SIDs (Speed Indicator Devices) at the three village entrances, and possibly on School Lane.

Highworth Town Council recently installed SIDs and has found them effective. The approximate cost is £2,000 per camera. Cllr N Gardiner will contact Clerk Deanna Rose, copying us in, to request supplier details and any useful information, including costs, company details and any Swindon Borough Council approvals needed for camera pole locations.

The units are solar powered, and the cameras record vehicle numbers and speeds, and the data can be downloaded and submitted to the Borough Council as evidence. Funding may be available through the CBF.

At the village entrance on the C114, the speed limit changes from 40 mph to the national speed limit for approximately 170 metres before the 30-mph village limit. This encourages drivers to speed up briefly before braking sharply at the village entrance. Cllr N Gardiner will investigate how this can be addressed.

The road markings outside the playpark warning that children may be nearby have faded. How can these markings be renewed?

b. Bridleway

No change or update received from Swindon Borough Council. The Bridleway is still unusable due to the nature of the debris dumped there, it contains demolition material such as sharp broken tiles, thus making it unusable for horse riders or walkers.

Cllr N Gardiner will progress this.
